Recognition of Children, Family and Loved Ones Unable to be present.

During the ceremony is a good time to include family members by recognizing and mentioning them. In a second marriage the children of the first marriages can be recognized and included as part of the ceremony. Presentation of flowers or gifts can also be part of the recognition.

Recognition of Parents and Family is usually done before the Vows and Rings. Recognition of Children is usually done after the Vows and Rings. Presentation of Roses to Mothers can be done after the Recognition of Parents or done just after the Unity Candle Lighting which is usually after the Vows and Rings.

Recognition of those unable to be present due to illness, or military service, can be done toward the beginning of the ceremony.

Recognition of Parents and Families

To the parents of Bde and Grm, congratulations on the part you have played in raising a daughter and son of such serious purpose. They accept a very mature and meaningful task in taking on this marriage. On their behalf, and on behalf of everyone here, I thank you.

With this marriage we are not only joining these two separate lives, but also we are joining your two families. I remind you that it is more than their blood that is joined here; it is yours as well.

With this in mind, I ask you, Bde's parents, to take this man, Grm, as your son. I ask your family to take him into their hearts, as son and brother, and beloved to Bde.

And of you, Grm's parents, I ask the same. I ask that you take this woman, Bde, into your hearts, that she might live from this day as your

daughter. I ask the family as well to receive her as their sister, for she is dear and beloved to Grm.

May the blessing of this marriage extend throughout your families.
